## 5. Miscellaneous Services – Non Aviation

### Flat rate administrative charges

#### General

If services are provided, a flat rate for administrative costs may be charged, unless agreed otherwise.

#### Placement and acceptance of orders

Individual services will be carried out only by orders legally bound and at least in text form.

Placed orders do not substantiate any claims for execution of individual services; orders can be accepted only under reserve of feasibility of the individual services and deliveries to be carried out.

#### Execution of orders

The customer or recipient of services shall confirm on the order form that the order has been duly executed.

If the execution of an order cannot be confirmed the customer shall bear costs already arisen even in the case that he is not identical to the recipient of services.

#### Charging

Charges are based on complete units.

In case of calculation of administrative charges a cost unit rate of 12% will be raised.

If there is stipulated an hourly rate, the period of 30 minutes has to be taken as for the minimum rate if not stated otherwise.

The charges listed for the usage of vehicles and equipment are to be understood without driver or operational staff if not stated otherwise. Assistance by airport staff shall be charged separately.

All charges listed are to be understood without VAT.

### 5.1. Fees for services

#### 5.1.1. License fees for commercial photograph shootings and video recordings on the airport premises

Current reports are not subject to license fees. Additional services used within the scope of shootings and recordings are accounted for separately.

For all other shootings and video recordings, the Flughafen Leipzig/Halle GmbH will provide individual offers.

## 5.2. Fire Brigade

Regulations for the payment of costs for airport fire brigade services

### 5.2.1. Scope

#### 5.2.1.1.

The following regulations for the payment of costs apply for all services provided by the airport fire brigade.

#### 5.2.1.2.

Services provided by the airport fire brigade are chargeable and shall be paid to Flughafen Leipzig/Halle GmbH (hereafter referred to as "airport") according to these regulations.

### 5.2.2. Airport fire brigade services

The services defined in paragraph 5.2.14 of these regulations also encompass the following: dispatch of the fire brigade on a malicious false alarm, dispatch of the fire brigade on a false alarm caused by private fire alarm systems or usage of the public telecommunication routes by the operators of private fire alarm systems on the airport premises.

### 5.2.3. Structure of cost rates

#### 5.2.3.1.

The cost rates consist of:

- personnel costs for dispatched employees of the airport fire brigade,
- bonuses for difficult working conditions according to applicable law,
- hourly rates for the usage of vehicles of the airport fire brigade as transport space for crews, equipment and accessories,
- rates for the usage of equipment,
- costs for consumed materials and items,
- costs for the disposal of residues,
- costs for miscellaneous fire brigade services

#### 5.2.3.2.

Only airport fire brigade services and materials required for accomplishing a mission shall be included in the statement of costs. The statement of costs shows each individual item with its application and cost.

#### 5.2.3.3.

In departure of paragraph 5.2.3.2., in the event of a malicious false alarm or false alarm, the services and materials stated in the dispatch regulations of the airport fire brigade will be charged. In this case, the vehicles of the airport fire brigade which are to be dispatched will be treated as transport space as per paragraph 5.2.3.1.

### 5.2.4. Calculation of personnel costs

#### 5.2.4.1.

An officer-in-charge of the airport fire brigade and the task force required to accomplish a mission will be included in the statement of costs.

#### 5.2.4.2.

Hourly rates are applied for the calculation of personnel and hourly and daily rates for equipment costs. Any part of a half hour is rounded up to a half hour. For any time in excess of a half hour, a full hour is charged. The first chargeable hour commences with the alerting of the airport fire brigade. The end of the mission is considered as the time when the airport fire brigade re-establishes readiness for duty.

#### 5.2.4.3.

The bonuses for difficult working conditions calculated according to applicable law must be included in the statement of costs. These bonuses are applied for the task forces that are subjected to difficult working conditions during a mission.

### 5.2.5. Cost rates for the usage of equipment

#### 5.2.5.1.

Costs for the usage of equipment during an airport fire brigade mission are calculated with consideration of the technical properties of the individual pieces of equipment (equipment usage time).

#### 5.2.5.2.

The cost rates for the usage of equipment are stated in paragraph 5.2.14. If applicable, they include the consumed fuels and lubricants as well as average rates for maintenance, care and preventive maintenance; for vehicles, they additionally include the prescribed number of personnel required for operation.

#### 5.2.5.3.

The decision about the necessity of the usage of equipment is the responsibility of the officer-in-chief of the airport fire brigade.

#### 5.2.5.4.

In the event of renting equipment and accessories of the airport fire brigade, hourly or daily rates are applied. Any part of a calendar day counts as a full day of usage. Fuels and lubricants as well as energy consumption shall be charged to the renter.

### 5.2.6. Costs for consumed materials and items

#### 5.2.6.1.

In the event of a refund, the actual costs plus a 10% administration fee will be charged for consumed materials and items such as filter inserts, alkali cartridges, solid extinguishing agent, binding agent, water etc.

#### 5.2.6.2.

If special costs, such as travel expenses, repair costs, replacement costs in case of unserviceability or loss, are caused for the airport by utilization of its fire brigade, these costs must be charged separately.

### 5.2.7. Costs for the disposal of residues

If not otherwise stated in paragraph 5.2.14., the costs for the disposal of residues are included in the costs for consumed materials and items according to paragraph 5.2.6.

### 5.2.8. Cost rates for miscellaneous services

#### 5.2.8.1.

The deployment of members of the airport fire brigade in order to maintain fire safety is charged at an hourly-basis rate. The decision concerning the size of the task force deployed is the responsibility of the airport.

#### 5.2.8.2.

The cost rates for miscellaneous services are stated in paragraph 5.2.14.

## 5.2.9. Debtor

### 5.2.9.1.

There is an obligation to pay costs in the event of culpably caused hazards or damages as well as against the responsible party in cases of strict liability.

### 5.2.9.2.

In cases stated in paragraph 5.2.9.1., the payment of the costs is to be claimed from:

- the responsible party, if it has caused the hazard or damage deliberately or by gross negligence,
- the vehicle owner, if the hazard or damage was caused during the operation of rail vehicles, aircraft or motor vehicles,
- the operator, if the hazard or damage was caused during the transport, storage or use of flammable liquids or other hazardous substances.

### 5.2.9.3.

In cases of strict liability, the fact that objectively given additional considerations and duties of care were neglected at the time of a required mission is sufficient to constitute a claim for payment of expenses from services of the airport fire brigade.

## 5.2.10. Origination and maturity of the payment claim, co-debtor

### 5.2.10.1.

The airport's payment claim originates upon

- termination of utilization of the airport fire brigade,
- return of rented equipment and accessories belonging to the airport fire brigade,
- replacement or billing of consumed materials and items,
- demonstrable occurrence of special costs in accordance with paragraph 5.2.9.2.,
- completion of disposal of residues.

### 5.2.10.2.

The maturity of claims is in compliance with the general terms and conditions of the airport.

### 5.2.10.3.

Several debtors are held liable as co-debtor.

## 5.2.11. Waiver for payment claims

### 5.2.11.1.

In the below cases, there is payment obligation for services carried out by the airport fire brigade within the scope of the general assistance obligation, except for cases of intent:

- hostile fires
- public states of emergency caused by natural phenomena, collapses, accidents and the like,
- technical assistance in order to rescue humans and animals from a life-threatening situation,
- fire prevention and preventive fire protection excl. fire brigade safety duty,
- training missions of the fire brigade.

### 5.2.11.2.

The validity of agreements in individual contracts remains unaffected by this.

## 5.2.12. Liability

### 5.2.12.1.

The airport shall not be held liable for personal injury and material damage caused by the use of temporarily rented vehicles or equipment of the airport fire brigade. In these cases, the renting person is liable to pay for loss and damage of vehicles and equipment.

### 5.2.12.2.

The airport shall not be held liable for material damage which its personnel deemed necessary for the provision of the chargeable assistance service. In the case of a third party's property being damaged, the debtor internally agrees to indemnify the airport of claims made by third parties.

## 5.2.13. Transitional and final provisions

### 5.2.13.1.

For claims arising before these regulations became effective and whose payment lies after these regulations became effective, previous cost rates will be applied.

### 5.2.13.2.

The airport may choose not to issue notifications for the payment of costs at their own discretion.



## 5.2.13.3.

The airport is entitled to adjust the above regulations for the payment of costs and the cost rates and, whenever new materials are acquired, to amend the regulations with applicable cost rates. The duty of publication remains unaffected by this.

## 5.2.14. Cost rates airport fire brigade

If personnel services are provided using personal protective equipment (heat protection suit and chemicals protection suit) or if special decontamination works (e.g. prevention of damages due to flammable liquids, ground water or caustic substances) are performed, a 25% surcharge will be applied.
